SECTION 4) FIRST-AID MEASURES

Inhalation

Remove source of exposure or move person to fresh air and keep comfortable for breathing. If breathing is difficult, trained personnel should administer emergency oxygen if advised to do so by the POISON CENTER/doctor.

Eye Contact

Gently brush product off face. Do not rub eyes. Let the eyes water naturally for a few minutes. Look right and left, then up and down. If eye irritation persists: Get medical advice/attention. Do not attempt to manually remove anything from the eyes. Rinse eyes cautiously with lukewarm, gently flowing water for several minutes, while holding the eyelids open. Remove contact lenses, if present and easy to do. Continue rinsing for a duration of 15-20 minutes. Take care not to rinse contaminated water into the unaffected eye or onto the face.

Skin Contact

Take off contaminated clothing, shoes and leather goods (e.g. watchbands, belts). Wash with plenty of lukewarm, gently flowing water for a duration of 15-20 minutes or until medical aid is available. If skin irritation occurs: Get medical advice/attention. Wash contaminated clothing before reuse.

Ingestion

Rinse mouth. If you feel unwell/lf concerned: Get medical advice/attention.

Small Fire: Dry chemical, foam, carbon dioxide, water-spray or alcohol-resistant foam. Carbon dioxide can displace oxygen. Use caution when applying carbon dioxide in confined spaces. Large Fire: Water spray, fog or alcohol-resistant foam.

Unsuitable Extinguishing Media

Do not use straight stream of water.

Specific Hazards in Case of Fire

Fire will produce irritating gases.

Fire-fighting Procedures

Isolate immediate hazard area and keep unauthorized personnel out. Stop spill/release if it can be done safely. Move undamaged containers from immediate hazard area if it can be done safely. Cool containers with flooding quantities of water until well after fire is out. Dispose of fire debris and contaminated extinguishing water in accordance with official regulations.

Special Protective Actions

Wear protective pressure self-contained breathing apparatus (SCBA) and full turnout gear.

SECTION 6) ACCIDENTAL RELEASE MEASURES

Emergency Procedure

Isolate hazard area and keep unauthorized personnel away. Ventilate closed spaces before entering. Do not touch damaged containers or spilled materials unless wearing appropriate protective clothing.

Recommended Equipment

Wear chemical protective clothing and positive pressure self-contained breathing apparatus (SCBA).

Personal Precautions

Avoid breathing dust. Avoid contact with skin, eye or clothing.

Environmental Precautions

Stop spill/release if it can be done safely. Prevent spilled material and water from clean-up/firefighting from entering sewers, storm drains, other unauthorized drainage systems and natural waterways by using sand, earth, or other appropriate barriers.

Methods and Materials for Containment and Cleaning up

Avoid raising dust. Safely collect powdered material and deposit in sealed containers for disposal. Ventilate and wash area after clean-up is complete

SECTION 7) HANDLING AND STORAGE

General

Wash hands after use. Avoid contact with skin, eye or clothing. Avoid breathing dust. Use good personal hygiene practices. Eating, drinking and smoking in work areas is prohibited. Remove contaminated clothing and protective equipment before entering eating areas. All containers must be properly labelled. Storage Room Requirements

Store in a cool, dry, well ventilated area, away from sources of ignition and incompatibilities. Keep containers securely sealed when not in use. Containers that have been opened must be carefully resealed to prevent leakage. Indoor storage should meet OSHA standards and appropriate fire codes. Empty containers retain residue and may be dangerous.

Skin Protection

Launder soiled clothes or properly disposed of contaminated material, which cannot be decontaminated.
