SECTION 4) FIRST-AID MEASURES

Inhalation

Remove source of exposure or move person to fresh air and keep comfortable for breathing. If breathing is difficult, trained personnel should administer emergency oxygen if advised to do so by the POISON CENTER/doctor. Immediately call a POISON CENTER or doctor.

Eye Contact

Rinse eyes cautiously with lukewarm, gently flowing water for several minutes, while holding the eyelids open. Remove contact lenses, if present and easy to do. Continue rinsing for a duration of 30 minutes or until medical aid is available. Take care not to rinse contaminated water into the unaffected eye or onto the face. Immediately call a POISON CENTER or doctor.

Skin Contact

Rinse with lukewarm, gently flowing water for 5 minutes or until product is removed. Take off immediately all contaminated clothing, shoes and leather goods (e.g. watchbands, belts). Rinse skin with lukewarm, gently flowing water/shower for a duration of 30 minutes or until medical aid is available. Immediately call a POISON CENTER or doctor. Wash contaminated clothing before re-use or discard.

Ingestion

Rinse mouth. Do NOT induce vomiting. Immediately call a POISON CENTER or doctor. If vomiting occurs naturally, lie on your side, in the recovery position.

SECTION 5) FIRE-FIGHTING MEASURES

Suitable Extinguishing Media

Small Fire: Dry chemical, foam, carbon dioxide, water-spray or alcohol-resistant foam. Carbon dioxide can displace oxygen. Use caution when applying carbon dioxide in confined spaces. Large Fire: Water spray, fog or alcohol-resistant foam.

Unsuitable Extinguishing Media

Do not use straight stream of water.

Specific Hazards in Case of Fire

Fire will produce irritating and corrosive gases.

Fire-fighting Procedures

Isolate immediate hazard area and keep unauthorized personnel out. Stop spill/release if it can be done safely. Move undamaged containers from immediate hazard area if it can be done safely. Cool containers with flooding quantities of water until well after fire is out. Caution should be exercised when using water or foam as frothing may occur, especially if sprayed into containers of hot, burning liquid. Dispose of fire debris and contaminated extinguishing water in accordance with official regulations.

Special Protective Actions

Wear protective pressure self-contained breathing apparatus (SCBA) and full turnout gear.

SECTION 6) ACCIDENTAL RELEASE MEASURES

Emergency Procedure

Isolate hazard area and keep unauthorized personnel away. Stay uphill and/or upstream. Ventilate closed spaces before entering. Do not touch damaged containers or spilled materials unless wearing appropriate protective clothing.

Recommended Equipment

Wear chemical protective clothing and positive pressure self-contained breathing apparatus (SCBA).

Personal Precautions

Avoid breathing vapor or mist. Do not get on skin, eyes or clothing.

Environmental Precautions

Stop spill/release if it can be done safely. Prevent spilled material from entering sewers, storm drains, other unauthorized drainage systems and natural waterways by using sand, earth, or other appropriate barriers.

Methods and Materials for Containment and Cleaning up

Absorb Liquids in vermiculite, dry sand, earth, or similar inert material and deposit in sealed containers for disposal. Ventilate area after clean-up is complete.

SECTION 7) HANDLING AND STORAGE

General

Wash hands after use. Avoid breathing vapor or mist. Use good personal hygiene practices. Eating, drinking and smoking in work areas is prohibited. Remove contaminated clothing and protective equipment before entering eating areas. Eyewash stations and showers should be available in areas where this material is used and stored All containers must be properly labelled. Do not get in eyes, on skin, or on clothing.

Ventilation Requirements

Use only with adequate ventilation to control air contaminants to their exposure limits. The use of local ventilation is recommended to control emissions near the source. Report ventilation failures immediately.

Storage Room Requirements

Store in a cool, dry, well ventilated area, away from sources of ignition and incompatibilities. Keep containers securely sealed when not in use. SECTION 8) EXPOSURE CONTROLS/PERSONAL PROTECTION

Eye protection
