# **SECTION 4) FIRST-AID MEASURES**

#### **Inhalation**

Remove source of exposure or move person to fresh air and keep comfortable for breathing. If breathing is difficult, trained personnel should administer emergency oxygen if advised to do so by the POISON CENTER/doctor. Immediately call a POISON CENTER or doctor.

#### **Eve Contact**

Gently brush product off face. Do not rub eyes. Let the eyes water naturally for a few minutes. Look right and left, then up and down. Do not attempt to manually remove anything from the eyes. Rinse eyes cautiously with lukewarm, gently flowing water for several minutes, while holding the eyelids open. Remove contact lenses, if present and easy to do. Continue rinsing for a duration of 30 minutes or until medical aid is available. Take care not to rinse contaminated water into the unaffected eye or onto the face. Immediately call a POISON CENTER or doctor.

## **Skin Contact**

Take off immediately all contaminated clothing, shoes and leather goods (e.g. watchbands, belts). Rinse skin with lukewarm, gently flowing water/shower for a duration of 30 minutes or until medical aid is available. Immediately call a POISON CENTER or doctor. Wash contaminated clothing before re-use or discard.

## Ingestion

# **SECTION 5) FIRE-FIGHTING MEASURES**

# **SECTION 6) ACCIDENTAL RELEASE MEASURES**

## **Emergency Procedure**

Ventilate closed spaces before entering. Do not touch damaged containers or spilled materials unless wearing appropriate protective clothing. Evacuate and isolate hazard area and keep unauthorized personnel away.

#### **General**

Wash hands after use. Avoid breathing dust. Use good personal hygiene practices. Eating, drinking and smoking in work areas is prohibited. Remove contaminated clothing and protective equipment before entering eating areas. All containers must be properly labelled. Do not get in eyes, on skin, or on clothing. Eyewash stations and showers should be available in areas where this material is used and stored

#### **Ventilation Requirements**

Use only with adequate ventilation to control air contaminants to their exposure limits. The use of local ventilation is recommended to control emissions near the source. Report ventilation failures immediately.

#### **Storage Room Requirements**
