SECTION 4) FIRST-AID MEASURES

Inhalation

SECTION 5) FIRE-FIGHTING MEASURES

Suitable Extinguishing Media

Alcohol resistant foam. Water spray. Carbon dioxide (CO2). Dry chemical powder.

Unsuitable Extinguishing Media

Do not use straight stream of water.

Specific Hazards in Case of Fire

Product is not flammable. Dust/air mixtures may ignite or explode. In case of combustion it may generate carbon monoxide, besides CO2.

Fire-fighting Procedures

Wear positive pressure self-contained breathing apparatus (SCBA) and full turnout gear.

SECTION 6) ACCIDENTAL RELEASE MEASURES

Emergency Procedure

Isolate hazard area and keep unauthorized personnel away. Stay uphill and/or upstream. Do not touch damaged containers or spilled materials unless wearing appropriate protective clothing. Ventilate closed spaces before entering.

Recommended Equipment

Wear chemical protective clothing.

Personal Precautions

Avoid breathing vapor or mist. Avoid contact with skin, eye or clothing.

Environmental Precautions

Stop spill/release if it can be done safely. Prevent spilled material from entering sewers, storm drains, other unauthorized drainage systems and natural waterways by using sand, earth, or other appropriate barriers. Dike far ahead of liquid spill for later disposal.

Methods and Materials for Containment and Cleaning up

Absorb Liquids in vermiculite, dry sand, earth, or similar inert material and deposit in sealed containers for disposal.

SECTION 7) HANDLING AND STORAGE

General

Wash hands after use. Do not get in eyes, on skin or on clothing. Do not breathe vapors or mists. Use good personal hygiene practices. Eating, drinking and smoking in work areas is prohibited.
