SECTION 4) FIRST-AID MEASURES

Inhalation

Get medical advice/attention if you feel unwell or are concerned. If experiencing respiratory symptoms: Call a POISON CENTER/doctor.

Remove source of exposure or move person to fresh air and keep comfortable for breathing. If breathing is difficult, trained personnel should administer emergency oxygen if advised to do so by the POISON CENTER/doctor.

Eve Contact

Immediately call a POISON CENTER/doctor. Rinse eyes cautiously with lukewarm, gently flowing water for several minutes, while holding the eyelids open. Skin Contact

until medical aid is available.

SECTION 5) FIRE-FIGHTING MEASURES

Suitable Extinguishing Media

Foam, water fog, dry chemical, carbon dioxide

Do NOT direct a solid stream of water or foam into burning molten material; this may cause spattering and spread the fire.

Specific Hazards in Case of Fire

Fire-fighting Procedures

Special Protective Actions

SECTION 6) ACCIDENTAL RELEASE MEASURES

Emergency Procedure

Methods and Materials for Containment and Cleaning up

Prevent the influx to waterways, sewers, basements or confined spaces.

Ventilate area after clean-up is complete. Absorb Liquids in vermiculite, dry sand, earth, or similar inert material and deposit in sealed containers for disposal.

SECTION 7) HANDLING AND STORAGE

General
