Suitable Extinguishing Media

Water spray. Alcohol resistant foam. Carbon dioxide (CO2). Dry chemical powder.

Unsuitable Extinguishing Media

Specific Hazards in Case of Fire

SECTION 6) ACCIDENTAL RELEASE MEASURES

Emergency Procedure

Isolate hazard area and keep unauthorized personnel away. Stay uphill and/or upstream. Do not touch damaged containers or spilled materials unless wearing appropriate protective clothing. Ventilate closed spaces before entering.

Recommended Equipment

Wear chemical protective clothing.

Personal Precautions

Avoid breathing vapor or mist. Avoid contact with skin, eye or clothing.

Environmental Precautions

Stop spill/release if it can be done safely. Prevent spilled material from entering sewers, storm drains, other unauthorized drainage systems and natural waterways by using sand, earth, or other appropriate barriers. Dike far ahead of liquid spill for later disposal.

Methods and Materials for Containment and Cleaning up

Absorb Liquids in vermiculite, dry sand, earth, or similar inert material and deposit in sealed containers for disposal.

SECTION 7) HANDLING AND STORAGE

General

Avoid inhalation and contact with eyes, skin or clothing through proper protection. If occurs accidental contact, exposed area should be washed immediately. Wash hands after use. Do not get in eyes, on skin or on clothing. Do not breathe vapors or mists. Use good personal hygiene practices. Eating, drinking and smoking in work areas is prohibited. Remove contaminated clothing and protective equipment before entering eating areas. Eyewash stations and showers should be available in areas where this material is used and stored All containers must be properly labelled.

Skin Protection
