SECTION 4) FIRST-AID MEASURES

Inhalation

Eye Contact

If irritation occurs, cautiously rinse eyes with lukewarm, gently flowing water for 15 minutes, while holding the eyelids open.

Skin Contact

SECTION 5) FIRE-FIGHTING MEASURES

Suitable Extinguishing Media

General
